**LEGAL NOTICE - THROUGH RPAD**

This notice is emanated under the instructions of my client D.R. Anil Kumar S/o D Ramkishan Rao, aged about 52 years, Occ: Proprietor D.R Anil Kumar Construction, having its address at 202, 8-2-310/31/A, Hill Top Residency, Road No.4, Banjara Hills, Hyderabad as follows:

1. My client M/s D.R Anil Kumar Construction is doing business in Construction in the vicinity of Telangana as well as other neighboring States for past many years and leading business successfully.
2. That on 09-12-2025 you recklessly with malice intention aired the false and baseless statements made by MLA Madhavaram Krishna Rao. The derogatory statements made by MLA Madhavaram Krishna Rao against my client and her family member over Your television 'T' News Telugu News Channel, the same was telecasted, viewed by millions of people over, T.V, Social Media, YouTube and other online platforms.
3. The alleged information's and statements made by MLA Madhavaram Krishna Rao is being spread by you is unverified,

incorrect and inadequate. You with negative intention to defame my client and his family reputation, aired and telecasted misleading information or information that were made by suppressing material facts is being placed in Your T News Channel by way of Electronic Media and Print Media with sole intention to tarnish the image of my client and character assassination of his family, running statements made by MLA Madhavaram Krishna Rao - phrases as such:

“Running false propaganda of grabbing Government Land and overlapping survey numbers in Moosapet Village”

“Projecting my client’s wife as Gambler,

“Purporting my client and his wife as Extortionist”.

“Judging Character of My client’s wife”, (T NEWS Channel)”

passing slanderous statements against my client’s wife by “Madhavaram Krishna Rao:

“If I start speaking about your character, ‘you will commit suicide’ and you will not be able to survive in Telangana’

Called my wife ‘Donga Dorsani”


“Comparing her with dogs”

Taunting my client by calling him

‘Husband of liquor queen”

“Have your father has capacity and rights to purchase properties in Hyderabad”,


“Raised allegations against my client and his family that they are Blackmailing Leaders and extorting Crores of rupees”.





My client and his family members were "Criminally Intimidated" and "Mentally tortured" time and again.

4. My client in due course of his business activity in good faith has been part of a land transaction pursuant to the Award passed by the Lok Adalat, confirmed by the Hon'ble High Court of Telangana in respect of a Private Patta Land only after verification and due diligence. You have published the contents that were dishonestly projecting the same as Government Land which have not only defamed my client and his family but also repeatedly used unparliamentary language against my client's wife, the sanctity of a lady who has served as MP and MLC and a Women who has sacrificed everything for the formation of Telangana State and to establish Women Empowerment in State of Telangana, which was predominant by Males earlier.
5. You without verifying the checkers history of land in Sy.No. 210/2, 210/3 and 210/4, Moosapet Village, Kukatpally Mandal, Medchal- Malkajgiri has aired with malice and negative intention with sole aim to damage the reputation of my client and his family members. The land dispute in survey numbers mentioned by MLA Madhavaram Krishna Rao was resolved before Competent Court and Lok Adalat Award was passed, which has attained finality. Subsequently the said land was sold, airing such derogatory statements in this regard is nothing but Slandering the name of my client and his family. When the matter is settled through court orders, a false propaganda is being aired and published in Your T News Channel, questioning the integrity of the Hon'ble Court Order without challenging the same is unsustainable and uncalled-for.



6. You have intentionally published derogatory statements made by MLA Madhavaram Krishna Rao against my client and his family members without going through the legal documents in its entirety and court orders, records available with Revenue Department, Memos issued by various Government Officials, Proceedings Passed by Revenue Department, HMDA, MA & UD and other various departments.
7. The imputations made by MLA Madhavaram Krishna Rao against my client are false, baseless, malicious and malafide. You deliberately aired and made an attempt to defame and damage and lower the name and fame by telecasting in Your T News channel which mislead negatively the reputation of my client and his family members in public.
8. You without authenticating the facts alleged by MLA Madhavaram Krishna Rao, have telecasted accusations, permitted the contents to be aired on the Television, tried to make the false contentions a debatable topic to gain Television Rating Point or Target Rating Point. The scurrilous allegations against my client and his family member that You have aired have harmed the reputation of my client and his family member which is violation of fundamental right guaranteed under Article 21 of The Constitution of India. The statements of MLA Madhavarma Krishna Rao that You aired in Your T News channel were a deliberate act to harm the reputation of my client and his family members, distractive comments and criticisms intentionally to create negative and false perception attract prosecution for committing offence punishable under Section 356(1) & 356(2) of BNS, and also falls under the legal






framework of Cyber Crime and is punishable for (2) years imprisonment.

I hereby call upon all of you to tender an **unconditional public apology within 7 Days** of receiving this notice in every Electronic Media including social media and Print Media. Remove the defamatory contents from your T News Media Sources online, and also in social media and other online platforms including YouTube with immediate effect and refrain yourself from repeating the same in future. If you fail to do so, my client is of definite instruction to initiate proceedings against you for criminal defamation punishable under Section 356(1) & 356(2) of BNS, Cyber Crime and for the tort of libel and for damages for loss of reputation and exemplary damages, along with cancellation of Your T News Channel satellite rights, all at your risk as to costs and consequences thereof.
